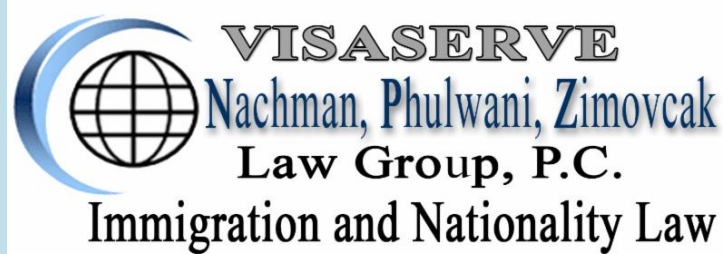

KNOW BEFORE YOU

Dear Readers:

This past week, several of the NPZ Lawyers continued to work remotely from our partners' offices in India. Our trip allowed us to "test the waters" about the new Trump Immigration law polices. The resounding opinion is that US isolationist policies hurt the US economy and drive jobs and innovation offshore.

On the DACA front, the University of California won a Preliminary Injunction in its DACA Appeal. The Court said that the rescission of DACA was based "solely on a misconceived view of the law" and is reviewable, and that plaintiffs are likely to succeed on their claim that it must be set aside.

On the Humanitarian Immigration Law front, President Trump issued a presidential proclamation targeting potential mass migration through the southern border of the United States with Mexico, in response to reports of a "caravan" of a large number of people primarily from Central America with a stated goal of entering the United States. DOJ and DHS published a related interim final rule limiting asylum claims, and the EOIR and USCIS released guidance. The ACLU and other groups have sued, claiming that the proclamation and rule violate asylum applicants' rights.

Labor announced several revisions to Form ETA-9035, the Labor Condition Application (LCA) for H-1B, H-1B1, and E-3 employment. The new LCA form incorporating these revisions was fully implemented on November 19th, 2018.

On the Family-based Immigration Law front, USCIS is issuing new receipt notices for certain Forms I-751, Petition to Remove Conditions on Residence, to replace previously issued receipt notices containing inaccurate information.

TRUMP ADMINISTRATION PROPOSES RULE TO LIMIT ASYLUM SEEKERS.

How would the Trump Administration's new law impact migrants seeking asylum?

In its latest move intended to crackdown on the number of immigrants in America, the Trump administration has issued a new rule that would ban migrants who cross the border anywhere outside of designated entry points from seeking asylum. Immediately after the rule was announced, the ACLU and other groups challenged the law, filing suit in federal court. Our asylum immigration lawyers at NPZ Law Group explore current asylum laws and why the proposed restrictions on asylum seekers should be declared illegal.

DHS PROPOSES MERIT-BASED RULE FOR MORE EFFECTIVE AND EFFICIENT H-1B VISA PROGRAM.

On November 30th, 2018, The Department of Homeland Security (DHS) announced a notice of proposed rulemaking that would require petitioners seeking to file H-1B cap-subject petitions to first electronically register with U.S. Citizenship and Immigration Services (USCIS) during a designated registration period. Under the proposed rule, USCIS would also reverse the order by which USCIS selects H-1B petitions under the H-1B cap and the advanced degree exemption, likely increasing the number of beneficiaries with a master's or higher degree from a U.S. institution of higher education to be selected for an H-1B cap number, and introducing a more meritorious selection of beneficiaries.

The H-1B program allows companies in the United States to temporarily employ foreign workers in specialty occupations that require the theoretical and practical application of a body of highly specialized knowledge and a bachelors or higher degree in the specific specialty, or its equivalent. When USCIS receives more than enough petitions to reach the congressionally mandated H-1B cap, a computer-generated random selection process, or lottery, is used to select the petitions that are counted towards the number of petitions projected as needed to reach the cap.

USCIS EXPANDS INFORMATION SERVICES MODERNIZATION PROGRAM TO NEWARK, NEW JERSEY, STARTING NOVEMBER 26TH 2018.

USCIS is currently expanding its Information Services Modernization Program to key field offices including the Newark District. Newark will end the self-scheduling of InfoPass in-person appointments at both Newark and Mt. Laurel Field offices on November 26th. On that date, both offices will stop accepting walk-ins and stop the self-scheduling of InfoPass appointments. Rather, appointments to visit USCIS Newark or Mt. Laurel (for example for passport stamps, advance parole or identity verification and true emergencies) can be made by contacting the USCIS Contact Center at 800-375-5283, Monday through Friday from 8 a.m. to 9 p.m. Eastern, except on federal holidays.

NEW USDOL FORM 9035 FOR H-1B VISAS PROMULGATED CONSISTENT WITH TRUMP'S "BUY AMERICAN - HIRE AMERICAN (BAHA)" INITIATIVES.

The US Department of Labor (DOL) announced revisions to Form ETA 9035, the Labor Condition Application (LCA) for H-1B, H-1B1, and E-3 employment. This was expected. We just did not know when the new Form was going to take effect.

Employers use the LCA to disclose and post information about wages and working conditions offered to professional temporary workers, as well as the prevailing wages for their occupation in the area of employment. The DOL has advised that a new Form incorporating these revisions will be fully implemented on November 19th, 2018.

KNOW BEFORE YOU GO: NPZ LAW GROUP HELPS EASE THE STRESS OF HOLIDAY TRAVEL FOR CERTAIN FOREIGN NATIONALS.

This the season to be jolly . . . but it is also the season when international travel can be a folly. Many foreign nationals will be traveling outside the U.S. during the holidays. This holiday travel usually extends from the end of November through the middle of February. Of course, for some, holiday travel often seems to entail a visit to the friendly Customs and Border Protection (CBP) Officer. For others, holiday travel may entail a visit to the U.S. Consulate Office in a home or third-country.

CONSTITUTIONAL?

President Trump recently made the shocking pronouncement that he intends to end birthright citizenship. Trump declared to news media sources that he wishes to advance his agenda to end birthright citizenship through an executive order. Trump urged that the U.S. is the only country where a person can enter illegally and have a baby, with the baby then becoming a U.S. citizen. Immediately, both opponents and supporters began to research and put forth their opinions on whether it would run afoul of the Constitution for Trump to put an end to birthright citizenship. USCIS CLARIFIES THE L-1 INTRACOMPANY TRANSFER VISA ONE-YEAR FOREIGN EMPLOYMENT REQUIREMENT.

USCIS has published a policy memorandum clarifying the requirement that a qualifying organization employ a principal L-1 beneficiary abroad for one continuous year out of the three years before the time of petition filing ("one-year foreign employment requirement"). This clarification is intended to ensure consistent adjudication of L-1 petitions by providing a standard basis for calculating time for the one-year foreign employment requirement.

DOS VISA BULLETIN UPDATE: VISA BULLETIN FOR DECEMBER 2018 - IF YOUR "PRIORITY DATE" IS CURRENT PLEASE LET US KNOW?

The December 2018 Visa Bulletin brings some welcome changes-a three month advancement across the EB-1 categories; the EB-2 China Final Action Date again surpassing EB-3 China; the gap between EB-2 India and EB-3 India narrowing to one month; EB-4 El Salvador, Guatemala and Honduras advancing one week; EB-4 Mexico advancing five weeks; and EB-5 China advancing one week, while EB-5 Vietnam advances three months.
