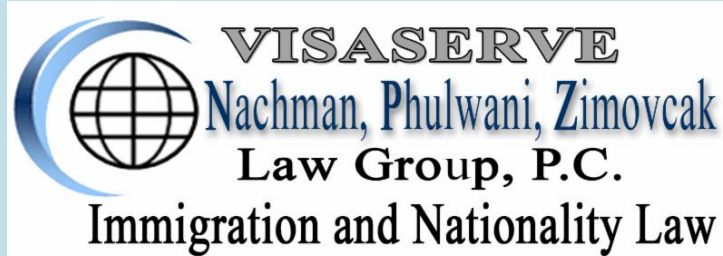

USCIS AND CBP EXTEND FORM I-129 PILOT PROGRAM FOR CANADIAN L-1

Dear Readers:

This week brought a deluge of US immigration law developments. The midterm elections bring a divided Congress. What this means for the future of US immigration policy is really anyone's guess.

In a surprising announcement, Jeffrey Sessions resigned from his position with the Justice Department at the behest of the President. While we could be "out of the frying pan and into the fire", we will continue to monitor this transition for our readers with very great interest.

On the DACA-front there is some good news. The 9th Circuit decided that DACA is subject to judicial review and granted preliminary injunctive relief to Plaintiffs affirming that rescission of DACA is "arbitrary, capricious, or otherwise not in accordance with law".

The approaching "Guatemala Caravan" (which conveniently coincided with the midterm elections) has now prompted the Trump Administration to announce a major change to US Asylum Policy. For almost 40 years, Congress has clearly stated that a foreign national who presents him/herself anywhere on the U.S. border or at a port of entry such as a harbor or airport has a right to claim asylum. The new policy clearly contradicts this longstanding law. Lawsuits have already

USCIS reminds that it will continue to prioritize cases of individuals with criminal records, fraud, or national security concerns and will continue to use "discretion in issuing NTAs".

Against Women Act self-petitions and Special Immigrant Juvenile Status petitions); I-730, Refugee/Asylee Relative Petitions when the beneficiary is present in the US; I-929, Petition for Qualifying Family Member of a U-1 Nonimmigrant; and I-485 Application to Register Permanent Residence or Adjust Status (with the underlying form types listed above).

If applicants, beneficiaries, or self-petitioners who are denied are no longer in a period of authorized stay and do not depart the United States, USCIS may issue an NTA. USCIS will continue to send denial letters for these applications and petitions to ensure adequate notice regarding period of authorized stay, checking travel compliance, or validating departure from the United States.

What are the requirements to receive a P-1 visa?

With temporary visas becoming scarcer for immigrants due to new caps and tightened restrictions, artists, entertainers, and athletes may apply for a P-1, P-2, or P-3 visa to secure their lawful status in the U.S. P visas are "dual intent" temporary worker visas that allow an individual to engage in certain kinds of work in the U.S. related to a unique talent or skill. For qualifying individuals, a P visa can prove effective in allowing you to pursue your dreams in America. USCIS AND CBP EXTEND FORM I-129 PILOT PROGRAM FOR CANADIAN L-1 NONIMMIGRANTS.

U.S. Citizenship and Immigration Services and the U.S. Customs and Border Protection (CBP) are extending the joint agency pilot program for Canadian citizens seeking L-1 nonimmigrant status under the North American Free Trade Agreement (NAFTA) through April 30th, 2019. Earlier this year, the USCIS California Service Center (CSC) and the CBP Blaine, Washington, port of entry (POE) announced this pilot program which was scheduled to run from April 30th, 2018, through October 31st, 2018.

This pilot program allows, but does not require, Canadian citizens to request that USCIS remotely adjudicate their petitioning employer's Form I-129 or I-129S prior to their arrival or when they arrive at the Blaine POE.

cutoff date for China advances by six weeks, to May 15th, 2015.

In the employment-based, fourth preference category (EB-4), the cutoff date for Mexico advances by one month, to November 22nd, 2016. Meanwhile, in the employment-based, fifth preference (EB-5) category, Vietnam's cutoff date moves up by a month, to February 1st, 2016. The only other change is that the EB-4 category for certain religious workers and the EB-5 category for regional center cases are no longer listed as unavailable. This is because the programs were yet again extended, this time until December 7th, 2018.

Quanto tempo leva para obter o green card para o meu cônjuge?

A cada ano, dezenas de milhares de americanos se casam com pessoas de outros países. Estrangeiros que casam com cidadãos dos Estados Unidos ou residentes permanentes a princípio podem se tornar cidadãos permanentes dos EUA ao obter o green card. As aplicações para o green card com base em casamento são as mais procuradas e, geralmente, a concessão do green card nesses casos é mais rápida do que nas outras categorias. Porém, com a repressão à imigração que vem sendo realizada pelo governo Trump, as aplicações com base em casamento estão passando por análise minuciosa, o que pode gerar atrasos.

WHAT IS THE REQUEST FOR EVIDENCE: H-1B REQUEST FOR EVIDENCE (RFE) - WHAT IT IS AND WHY DOES ONE ISSUE?



Receiving a Request-For-Evidence (RFE) during an H-1B visa petition or H-1B transfer or H-1B extension has become normal opposed to when it used to be a taboo prior to 2008 when the USCIS very rarely asked for more information. Today the RFE is more of a norm than an aberration. These days the possibility of getting an RFE is in nearly 41% of the cases and it is not really anything bad. It is only the USCIS wanting more information from the petitioner in order to make sure the petition for the job being filed really exists and if the candidate really qualifies. Some of the various types of queries in RFEs are as follows: (1) Various H-1B worksites; and (2) Level of Professional work available for H-1B workers; and (3) Financial stability of the H-1B employer; and (4) Whether the individual seeking H-1B status maintained nonimmigrant visa status.
