Dear Reader,

The Trump administration is preparing a new rule targeting the H-1B visa program, shortly after announcing a proposed \$100,000 fee for many H-1B visa holders. The forthcoming rule aims to tighten eligibility, increase oversight of employers, and limit third-party placements. Expected by the end of 2025, these measures could make it more challenging for U.S. companies to hire and retain foreign professionals in specialized fields, echoing a 2020 Trump-era attempt that was blocked by the courts.

Meanwhile, a federal judge has ruled that international students and faculty are entitled to the same First Amendment protections as U.S. citizens, striking down a Trump-era policy that targeted noncitizens for arrest or deportation over pro-Palestinian political speech. The court reaffirmed that freedom of expression extends to all individuals within the United States, regardless of immigration status.

USCIS IMPLEMENTS NEW \$1,000 IMMIGRATION PAROLE FEE UNDER H.R. 1.

The U.S. Citizenship and Immigration Services (USCIS) has announced a significant new policy update: beginning October 16, 2025, individuals granted immigration parole or re-parole will be required to pay a \$1,000 Immigration Parole Fee. This change is being implemented pursuant to the H.R. 1 Reconciliation Bill, which authorizes the Department of Homeland Security (DHS) to establish this new fee.

THE 2026 DIVERSITY VISA LOTTERY IS OPEN: WHAT YOU NEED TO KNOW.

The U.S. Department of State has opened the Diversity Immigrant Visa (DV) Lottery for Fiscal Year 2026. Often called the *Green Card Lottery*, this program offers up to 55,000 immigrant visas each year to people from countries with historically low levels of immigration to the United States.

U.S. Citizenship and Immigration Services (USCIS) has launched a new, large-scale internal initiative aimed at detecting fraud and improving data verification across immigration filings. Internally referred to as "Operation Twin Shield," the program marks one of the most extensive vetting efforts in recent years — and it is already affecting processing times for family-based, employment-based, and naturalization cases.

All participating employers, HR professionals, and federal contractors should take immediate action to ensure continued compliance with employment verification requirements.

The U.S. Citizenship and Immigration Services (USCIS) has announced that it will continue processing H-1B, H-2A, H-2B, and CW-1 petitions during the government shutdown. However, employers and petitioners should be aware that the shutdown may delay access to required Department of Labor (DOL) certifications, which could affect the timely filing of petitions such as Form I-129 and Form I-129CW.
